3) State Environment Impact Assessment Authority (SEIAA), Punjab has examined the proposal for Group Housing Project namely "Noble Aurelia" at site no. 5, Sector 88, SAS Nagar for total land area of 40,461.32 sq.m. and built up area of 3,19,667.53 sq.m. The project is covered under category 8(b) of the schedule appended with the EIA Notification dated 14.09.2006 and its subsequent amendments, and requires appraisal at the State Level.

4) The proposal has been appraised as per the procedure prescribed under the provisions of EIA Notification 14.09.2006 based on mandatory documents enclosed with the online application viz Form-1, Environment Management Plan (EMP), conceptual layout plan, and additional documents and subsequent presentation/clarifications made by the project proponent and his consultant to the observations of the State Expert Appraisal Committee (SEAC).

6) As per the submissions by the project proponent, to the effect that no land covered under the Forest Conservation Act, 1980, is involved in the project and no wildlife area covered under the Wildlife (Protection) Act, 1972 is involved in the project. Further, no litigation is pending in respect of the land on which the project is to be developed.

7) The SEAC, constituted under the provision of the EIA Notification, 2006 and comprising of expert members/domain experts in various fields, has examined the proposal submitted by the project proponent in the desired form along with the EMP report prepared and submitted by the consultant accredited by the Quality Council of India (QCI)/ National Accreditation Board for Education and Training (NABET) on behalf of the project proponent in its 317th meeting held on 17.06.2025.

8) After detailed deliberations and as per the details mentioned in the application proposal and subsequent presentation/clarification made by the Project Proponent and his Consultant during the meeting, the Committee decided to forward the case to SEIAA with the recommendations to grant Environmental Clearance to the Group Housing Project namely "Noble Aurelia" at site no. 5, Sector 88, SAS Nagar subject to the standard conditions.

9) The case was considered by SEIAA in its 315th meeting held on 27.06.2025 & 323rd meeting held on 13.11.2025. After detailed deliberation, the SEIAA decided to accept the recommendations of SEAC with agreed amendments as above and to grant the Environmental Clearance to the Group Housing Project namely "Noble Aurelia" at site no. 5, Sector 88, SAS Nagar for total land area of 40,461.32 sq.m. and built up area of 3,19,667.53 sq.m. subject to the standard conditions as proposed by SEAC and additional/amended conditions.

10) Accordingly, SEIAA, Punjab hereby accords Environmental Clearance to the aforesaid project under the provisions of EIA Notification dated 14.09.2006 and its subsequent amendments subject to proposed measures and strict compliance with terms and conditions as per Annexure-1.

11) The SEIAA reserves the right to stipulate additional conditions if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time-bound manner. SEIAA may revoke or suspend the environmental clearance if the implementation of any of the above conditions is not found to be satisfactory.

12) Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

13) This issues as per the decision taken by the Competent Authority.

1. Additional/amended Conditions

1.1	The project proponent shall remain responsible for compliance of all conditions stipulated in the Environmental Clearance and adherence to applicable environmental laws until the Environmental Clearance is transferred in the name of the transferee or the resident welfare association, as applicable. In such case both the parties shall approach the SEIAA with joint consent for transfer of Environmental Clearance
1.2	The amount allocated for EMP/AEA activities shall be maintained in a separate bank account by the project proponent. The project proponent shall submit periodic audited financial reports and outcomes achieved by utilization of funds reserved for implementation of EMP/AEA activities
1.3	Dedicated and regular Environmental Officer/Manager with requisite technical qualification (B.tech/Diploma in Civil/Chemical Tech/ Environmental Sciences) shall be deputed for continuous compliance of conditions of Environmental Clearance / activities and maintenance of record of the same
1.4	The project proponent shall make the project a "ZERO WASTE TO LANDFILL" and accordingly shall make an agreement with authorized recyclers for the management of dry waste as per Solid Waste Management Rules, 2016 and submit a copy of this agreement
1.5	The project proponent shall submit a copy of the agreement made with the authorized dumping site for disposing of the inert waste generated, after segregating the waste, into their landfill site
1.6	The project proponent shall get the design of Rain Water Harvesting System approved/vetted from Central Ground Water Authority (CGWA) accredited design consultants within 03 months, if applicable
1.7	The project proponent shall obtain NOC/permission from PWRDA for abstraction of ground water, as applicable
1.8	The project proponent shall install anti-smog guns for the construction and demolition activities in the project, strictly in compliance with the CPCB and other relevant applicable norms

1.9	The project proponent shall obtain a STP Design Adequacy Certificate prior to installation and a Performance Adequacy Certificate during the operation phase of the proposed STP from an IIT/NIT/ Institute of repute

1.11	The project proponent shall implement the AEA plan as per Part-B of the EMP and timelines agreed therein. For activities where no specific timeline is provided for implementation, the same have to be completed within 24 months
1.12	The present Environmental Clearance is accorded on a conceptual basis, as per the plans, drawings, and details submitted by the Project Proponent. In the event of any change, modification, or deviation in the approved layout, built-up area, green area, land use, configuration, or any other project parameter from the conceptual plan considered during the appraisal, the Project Proponent shall be required to obtain an amendment/revision in Environmental Clearance (subject to the provisions of MoEF&CC OM dated 10.09.2025) prior to undertaking any construction or development based on the revised planning. The project proponent shall submit a copy of the approved layout plan to SEIAA Punjab
1.13	The project proponent shall ensure that the natural drainage channels in the project site including streams, drains, choes, creeks, rivulets, etc. are not disturbed so that the natural flow of rainwater, etc is not impeded or disrupted in any manner
1.14	The solid waste other than Hazardous Waste (dry as well as wet garbage) generated should be properly collected and segregated before disposal to Municipal Authorities in accordance with the Solid Waste (Management) Rules, 2016. No municipal waste should be disposed of outside the premises in contravention of relevant rules and by-laws. Adequate measures should be taken to prevent any odour in and around the project premises
1.15	In the event that the project proponent decides to abandon/close the project at any stage, he shall submit an application in the prescribed form along with requisite documents through PARIVESH to SEIAA for surrendering the Environmental Clearance as per the procedure prescribed in OM dated 29.03.2022 issued by the MoEF&CC. 11.5	The copies of the environmental clearance shall be submitted by the project proponent to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn have to publicly display the same for 30 days from the date of receipt

11.6	The project proponent shall upload the status of compliance of the stipulated environmental clearance conditions, including results of monitored data on their website and update the same on a half-yearly basis
11.7	The project proponent shall submit six-monthly reports on the status of the compliance of the stipulated environmental conditions on the website of the Ministry of Environment, Forest and Climate Change at the Environment Clearance portal and submit a copy of the same to SEIAA
11.8	The project proponent shall submit the environmental statement for each financial year in Form-V to the concerned Punjab Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently and put the same on the website of the company
11.9	The project proponent shall inform the Regional Office as well as SEIAA Punjab, the date of financial closure and final approval of the project by the concerned authorities, commencing the land development work and start of production operation
11.10	The project authorities must strictly adhere to the stipulations made by the Punjab Pollution Control Board and the State Government
11.11	The project proponent shall abide by all the commitments and recommendations made in the EIA/EMP report, commitments made during the public hearing and made to SEIAA / SEAC during their presentation
11.12	No further expansion or modifications in the project shall be carried out other than those permitted in this EC without prior approval of SEIAA. In case of deviation or alterations in the project proposal from those submitted to the Ministry/SEIAA for clearance, a fresh reference shall be made to the Ministry/SEIAA, as applicable, to assess the adequacy of conditions imposed and to include additional environmental protection measures required, if any

11.14	This Environmental Clearance is granted subject to the final outcome of related pending cases in the Hon'ble Supreme Court of India, Hon'ble High Courts, Hon'ble NGT and any other Court of Law as may be applicable to the project
